PILOT PROGRAM

LODGE INVESTIGATION OF CANDIDATES

As of September 1, 2010, I am instituting a Pilot Program to authorize the Grand Lodge A. F. & A. M. of Colorado to conduct background checks on candidates for Masonry from Constituent Lodges. This program will be voluntary to all constituent Lodges in Colorado for the remainder of this Masonic Year ending January 28, 2011. It will require the addition of language to all petitions for membership for all participating Colorado Lodges to include a waiver from the petitioner for this check to be conducted. The Program will also require, on the part of all participating Lodges, the payment of a fee to cover the cost of the background check to be paid by the candidate at the time of his submission his petition. All information received from the background check will become the property of the participating Lodge and subject to the vote of the Lodge for initiation of the candidate. GUIDELINES FOR CANDIDATE INVESTIGATIONS

PILOT PROGRAM, September 1, 2010

GRAND LODGE OF COLORADO

Please use the following guidelines for the use of the Pilot Program for the Investigation of Candidates. If you have questions or need clarification please contact the Grand Secretary, Ernie Pyle, at 719-623-5344 or erniepyle@coloradofreemasons.org.

- 1. <u>All</u> investigation reports will be generated from the Grand Lodge of Colorado. The Grand Lodge has contracted with a private company to do a fifty state criminal background check, social security number verification and a recent addresses verification check.
- 2. For each candidate you must send the original dated, signed and completely filled out waiver form with a check generated from your Lodge for \$15.00. Make the check out to the Grand Lodge of Colorado. If you are requesting more than one background investigation you may send only one check with a list of the petitioners. Please send your request by regular mail. Since this is a Grand Lodge Pilot Program you do not have to change your bylaws to collect this money from the petitioner.
- 3. A new 'Petition for the Degrees of Masonry' form has been developed. However, the Candidate Background Waiver form must be filled out separately for the use of the Grand Lodge only. This form will be returned to the Lodge so you can have the candidate sign it when you return his investigation report. The Lodge <u>must</u> keep the original Candidate Background Waiver form.
- 4. The Grand Lodge will submit the candidate information to the investigation company as soon as it arrives and will do everything possible to give the Lodge a speedy report. The investigation report <u>must</u> be returned to the candidate, but as it says in item number 3, the Lodge must keep the original signed Candidate Background Waiver form.
- 5. <u>Do not</u> have the Investigation Committee investigate this person before you get the report. Also, do not vote on the petitioner until you have received the report and have the Investigation Committee Recommendation.
- 6. The Grand Lodge will not keep copies of the Investigation Report. It is for the use of the local Lodge only.
